Fire inspectors are now enforcing stricter standards for Fire Houses, including separation of Fire & EMS supplies enforcement of DEA controlled substance protocols.

Matt has given State notice that we want to start process earlier to insure we can incorporate cost increases into carryover planning at year-end.

Budget shortfall is about \$211,000 per year. Both levies need to be replaced to cover this amount based on Matt's calculations. We have one of the lowest budgets in the area relative to the level of service provided. Most vehicles are beyond recommended replacement age. To reduce expenses to current revenue we will likely have to close a station and/or reduce staffing.
